# PARENT/GUARDIAN PERMISSION FORM FOR CAMP PENDOLA

1. As custodial parent(s) or guardian(s) of \_\_\_\_\_, I request that my child be permitted to participate at Camp Pendola. I understand and agree that my child's participation in Camp Pendola and its activities is completely voluntary, that no oral representations, statements, or inducements apart from the contents of the registration package have been made to me, and that I have familiarized myself with the program and activities in which my child will participate.
2. I recognize that certain hazards and dangers are inherent in Camp Pendola trips, activities, and outdoor programs. These risks include but are not limited to, the activities of hiking, archery, canoeing, swimming, and camping. I acknowledge that although Camp Pendola has taken safety measures in an attempt to minimize the risk of injury to participants, Camp Pendola can neither insure nor guarantee that the participants, equipment, vehicles and/or activities will be free of hazards, accidents and/or injuries. I therefore agree that I will instruct my child in the importance of knowing all safety rules and directions of camp leaders, for both my child's safety and the safety of all participants. I understand that my child may be transported as a part of this program, and I consent to this transportation.
3. I agree to direct my child to cooperate and comply with all reasonable directions and instructions from adult leaders at Camp Pendola, and to observe all camp rules of conduct. I understand that if my child fails to observe those rules, or otherwise becomes disruptive in camp, I will be notified, and I agree to come to Camp Pendola to take my child home. I understand and agree that any financial obligations resulting from vandalism, stealing, or related activity by my child will be my responsibility.
4. In consideration of Camp Pendola permitting my child to attend and participate in the program, I release, forever discharge, and promise not to sue the Roman Catholic Bishop of Sacramento, a corporation sole, and all its affiliated entities, employees, agents, and volunteers (the "Diocese") from all liability for any loss of damage, and any claim or demands therefore on account of serious or mortal injury to the body, injury to psyche, or injury to property of my child, whether caused by negligence or other conduct by the Diocese while the child is participating at Camp Pendola, or on or about the premises of the Diocese or any of its facilities or equipment.
5. I further agree to indemnify and hold harmless the Diocese from any loss, liability, damage, or cost it may incur due to the presence of my child on or about the premises of the Diocese, its facilities or equipment, or while participating at Camp Pendola, whether caused by negligence of the Diocese or otherwise.
6. I hereby grant to the Diocese the irrevocable and unrestricted right to use, reproduce, and publish photograph(s) or video(s) of my child, including his/her image and likeness for the Diocese, parish, or school publications, advertising, or website(s), or any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. I hereby release the Diocese from any and all claims, actions, and liability of whatever nature and relating to the use of said photograph(s) and or video(s). If this is not acceptable to you, please notify the Director in writing.
7. WILDERNESS TRIP INFORMATION: If my child is participating in a Camp Pendola Wilderness Trip, I understand that campers on wilderness trips will be in groups of no more than 12 youth. Each group will be assigned two counselors who have been trained as lifeguards and in camping skills, with at least one certified in Wilderness First Aid. For canoeing trips, counselors will be trained in canoe safety and rescue. Groups will be in contact with Camp Pendola by mobile radios and/or phones with daily scheduled check in. Ranger stations and/or other safety personnel will be notified of the group's presence and itinerary. Campers may be subject to extremes in weather, and will be held responsible for their own behavior on the trip.
