Thank you for inquiring about our financial aid and campership programs. We are proud to sponsor as many campers as possible through our financial aid and campership programs, but we need your help. To allow as many **children from different families as possible, we ask that you contribute** as much as you can toward the week for your child. The **Financial Aid Program** grants up to **\$100** per person to assist with camper fees. The **Campership Program** pays up to a full session of camp per person (**proof of income for year 2008 or 2009 is required for the Campership Program**). **Funds for both programs are limited.** .

Financial Aid Program (up to \$100 maximum grant per child) **Complete Section A and C** on the next page.

- A. Campers requesting Financial Aid must complete the **Financial Aid Form**.
- B. We ask that families pay as much of the camp fee as possible. **Please complete the Financial Aid Form and mail it with your child's Camper Registration Form and deposit of \$100.**

Confirmation of your financial aid will appear on your child's confirmation statement. The funds supporting the Financial Assistance Program come from the Monsignor Murrough C. Wallace Endowment Fund administered by the *Friends of Pendola* organization and the *Mel and Brian Vail Fund* administered by Pendola Center. These funds are extremely limited. Please be as specific as possible as to why you need the funds.

Campership Program (up to \$300 grant maximum per child.) **Complete All Sections** on the next page

Any **Campership Program** request received without the requested proof of income for year 2008 or 2009 **WILL NOT** be processed. To help as many individuals as possible, we have set up the following simple guidelines:

- A. Campers on Camperships may attend only **one week of camp per summer** or be a **C.I.T.**
- B. You **may not add to** campership funds with other funds to extend the camper's stay.
- C. **Campership funds are for those individuals who otherwise could not attend camp.**
- D. We ask that families pay as much of the camp fee as possible: **\$75 is the minimum per camper, requested from each family. \$25 is due at registration and the additional \$50 by June 15.** If this amount is beyond your means, please make other arrangements in advance by contacting the Lori Rosene, Camp Director at the Pendola Center Office (916-PEN-DOLA) or (916-733-0141)

We need to keep accurate records of the number and reasons for the Financial Aid and Camperships granted each summer. If you receive financial aid or campership funds, please consider having your child send a thank you note (first name only) which can be shared with our donors.

If you are not selected for financial or campership assistance and choose not to attend, your deposit will be returned. *Our standard refund policy as stated in our brochure applies to all other refund situations.*
