**Pendola Center Family Camp
Participant Consent Form**

As parent or guardian, (we) request that our family be permitted to participate at Family Camp. I understand and agree that the participation of my family members and/or guests of my family is completely voluntary, that no oral representations, statements, or inducements apart from the contents of the registration package have been made to me, and that I have familiarized myself with the program and activities in which we may participate.

I recognize that certain hazards and dangers are inherent in Pendola Center activities and programs. These risks include but are not limited to, the activities of hiking, archery, canoeing, swimming, and camping. I acknowledge that although Pendola Center has taken safety measures in an attempt to minimize the risk of injury to participants, Pendola Center can neither insure nor guarantee that the participants, equipment, vehicles and/or activities will be free of hazards, accidents and/or injuries. I therefore agree that I will instruct my family in the importance of knowing all safety rules and directions of camp leaders, for both our family's safety and the safety of all participants. I understand that we may be transported as a part of this program, and I consent to this transportation.

I agree to cooperate and comply with all reasonable directions and instructions from program leaders at Pendola Center, and to observe all camp rules of conduct. I understand that if I, or members of my family or guests of my family, fail to observe those rules, or otherwise becomes disruptive in camp, I will be notified, and agree to leave the program. I understand and agree that any financial obligations resulting from vandalism, stealing, or related activity will be my responsibility.

In consideration of Pendola Center permitting us to attend and participate in the program, I release, forever discharge, and promise not to sue the Roman Catholic Bishop of Sacramento, a corporation sole, and all its affiliated entities, employees, agents, and volunteers (the "Diocese") from all liability for any loss of damage, and any claim or demands therefore on account of serious or mortal injury to the body, injury to psyche, or injury to our property, whether caused by negligence or other conduct by the Diocese while participating at Pendola Center, or on or about the premises of the Diocese or any of its facilities or equipment.

I further agree to indemnify and hold harmless the Diocese from any loss, liability, damage, or cost it may incur due to our presence on or about the premises of the Diocese, its facilities or equipment, or while participating at Pendola Center, whether caused by negligence of the Diocese or otherwise.

I hereby grant to the Diocese the irrevocable and unrestricted right to use, reproduce, and publish photograph(s) or video(s) of myself and family members, including images and likenesses for the Diocese, parish, or school publications, advertising, or website(s), or any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. I hereby release the Diocese from any and all claims, actions, and liability of whatever nature and relating to the use of said photograph(s) and or video(s).
